



Jessie Duncan Elementary School – Schedule of Fees 2023/2024

In August 2019 the Minister of Education made the Order School Fees Regulation.
As a result, there are no basic school fees for 2023/2024

The Division has been directed through Ministerial Order to

- o Cease charging fees or costs for textbooks, workbooks, photocopying, printing or paper supplies.
- o Only charge amounts to cover projected costs of providing for the subject matter of the charge.
- o Post each school's approved fee schedule on the school's website.

The following fee schedule, which has been approved by the Board of Education, was developed by estimating the maximum potential costs.

| Families with 2 or more children | The first 2 children of the lesser fees are full fees and the 3 rd and subsequent child is 50% off of their designated fee. A family of 3 grade 1 – 12 partially funded students will total \$500.00 per year or \$90.00 per month from September to January after deducting the \$20.00/student application fee. A family of 3 grade 1 – 12 unfunded students will total \$1,250.00 per year or \$240.00 per month from September to January after deducting the \$20.00/student application fee. A family of 3 grade 1 – 12 School of Choice or Out of Area students will total \$1,250.00 per year, due in full at the time of registration. | | | | | |

ALL TRANSPORTATION FEES ARE DUE IN FULL BY JANUARY 1, 2024 and no payment plan is available after that date.

Fee refunds are available up to January 31, 2024 based on eligibility.
